## TRADEMARK ASSIGNMENT

THIS AGREEMENT is effective nunc pro tunc as of January 28, 1999 (the "Effective Date") between M. A. BELL COMPANY ("ASSIGNOR") and HALLIBURTON ENERGY SERVICES, INC. ("ASSIGNEE").

WHEREAS, M. A. BELL COMPANY, a corporation of the State of Missouri, having an address at 217 Lombard Street, St. Louis, MO 63102 is the owner, by assignment or agreement, of all right, title and interest in and to the United States trademark Registration Number 825170, Serial Number 75/250444, which registered March 7, 1967, for the mark LADLETOP, (hereinafter referred to as "TRADEMARK").

WHEREAS, HALLIBURTON ENERGY SERVICES, INC., a corporation of the State of Delaware, having a place of business at 2601 Beltline Road, Carrollton, TX 75006 is desirous of acquiring the ASSIGNOR's entire right, title and interest in and to said TRADEMARK and the goodwill connected therewith.

NOW, THEREFORE, for and in consideration of the sum of Ten Dollars (\$10.00) and other good and valuable consideration, the receipt of which is hereby acknowledged, ASSIGNOR does hereby Sell, Assign, and Transfer to ASSIGNEE, its successors and assigns ASSIGNOR's entire worldwide right, title and interest in and to said TRADEMARK together with the goodwill connected therewith, and the right to recover for past, present, and future infringement and damages of the TRADEMARK assigned under this Nunc Pro Tunc Trademark Assignment with the right to sue for and collect the same for its own use and benefit, and for the use and benefit of its successors, assigns and other legal representatives, as fully and entirely as the same would have been held and enjoyed by ASSIGNOR if this transfer to ASSIGNEE had not been made.

ASSIGNOR hereby covenants that it has the full right to convey the interest in said TRADEMARK herein assigned, and that it has not executed, and will not execute, any agreement in conflict herewith;

ASSIGNOR further agrees to execute and deliver, from time to time, all further instruments of conveyance, assignment and further assurances and perform all such other acts as may reasonably be required to transfer and assign all of ASSIGNOR's right, title and interest in and to and under said TRADEMARK.
