TRADEMARK ASSIGNMENT




NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged,

Assignor hereby warrants and represents that he has sole title and interest in and to the Mark WIREFLY, that he has not sold, assigned, transferred or hypothecated any interest in or to that Mark, and that he is fully authorized and empowered to enter into this Agreement and effectuate the transfer contemplated hereunder.
