WHEREAS Assignor is the owner of the trademark/service mark registration set forth in Exhibit 1 and incorporated herein by reference;



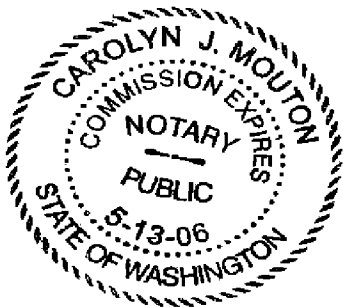

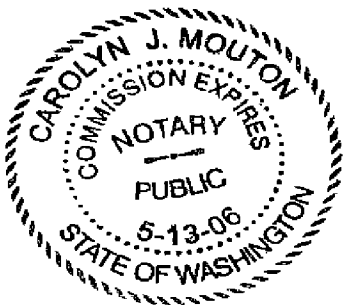
