Assignor hereby authorizes the Commissioner of Patents and Trademarks of the United States and other empowered officials of the United States Patent and Trademark Office and/or the appropriate empowered officials in relevant jurisdictions outside the United States to record the transfer of the registration included in the Trademarks to Assignee as assignee of Assignor's entire right, title and interest therein, and to issue to Assignee all trademark registrations referred to above which may issue with respect to the Trademarks in or outside the United States, in accordance with this Trademark Assignment.

Assignor further agrees, without further consideration, to take such further action and to execute such further assignments and other lawful documents as Assignee may reasonably request to effectuate fully this Assignment.

This instrument shall be governed by and construed in accordance with the law of the State of Delaware, without giving effect to principles of conflict of laws.

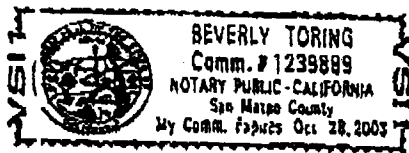
