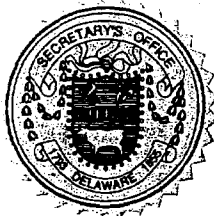


That the first paragraph is deleted in its entirety and replaced with the following:


"FIRST: The name of the limited liability company (hereinafter called the "limited liability company") is Serologicals Discovery Products, LLC."


That the sole member of the LLC and the managers (the "Managers") of the LLC have given their written consent in lieu of a meeting to said amendment.
