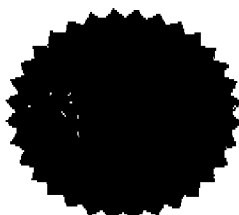

RESOLVED, that the Corporation merge, and it hereby does merge, into itself Fibre-Metal Delaware Inc. and assumes all of its obligations.


