**RELEASE OF U.S. SECURITY INTEREST**  
**(Citicorp)**

This Release of Security Interest, dated as of JANUARY 30, 2004, is made by Citicorp North America, Inc., as Administrative Agent ("Grantee"), in favor of The Warnaco Group, Inc., Warnaco Inc., and the other domestic subsidiaries of the Warnaco Group, Inc. (collectively, "Warnaco").

WHEREAS, pursuant to the Pledge and Security Agreement dated as of February 4, 2003 between Grantee and Warnaco (the "Security Agreement"), Warnaco granted to Grantee a security interest in the trademark registrations and applications listed on the attached Schedule A, and the goodwill associated therewith (the "Marks"); and

WHEREAS, Grantee, on behalf of all of the Secured Parties (as defined in the Security Agreement) hereby confirm that the security interest in all of the Marks has been discharged, terminated and released in all respects.


NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which the parties acknowledge, Grantee hereby (1) releases, discharges and relinquishes its security interest in all of the Marks, and (2) reassigns to Warnaco all right, title, and interest that Grantee may have had in the Marks, including all goodwill associated with the Marks. Grantee specifically acknowledges that the Security Agreement is no longer effective as to the Marks, and that Grantee does not own any rights to or have any ownership interest or claim in any of the Marks.

Grantee acknowledges and confirms that the terms and conditions of this Release of Security Interest shall be effective evidence of the release of the security interests in the Marks.
