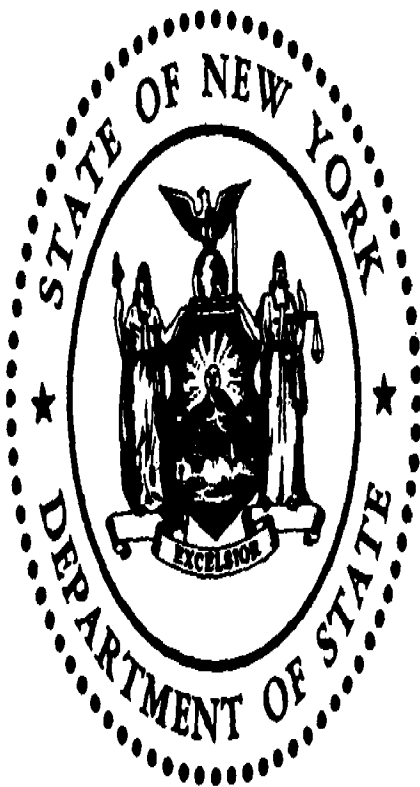

Bausch & Lomb Incorporated, pursuant to the provisions of Section 905 of the Business Corporation Law of the State of New York, hereby certifies as follows:

1. Bausch & Lomb Incorporated ("Bausch & Lomb"), a New York corporation, originally incorporated under the name of Bausch & Lomb Optical Company, owns all of the outstanding shares of stock of Polymer Technology Corporation ("PTC"), a New York corporation. PTC was originally incorporated under the name of Criterion Corp. Bausch & Lomb shall be the surviving corporation in the merger.

2. As to PTC, the designation and number of outstanding shares and the number of such shares owned by Bausch & Lomb are as follows:

3. (a) The Certificate of Incorporation of Bausch & Lomb was filed in the Department of State on March 20, 1908. It originally incorporated under the name of Bausch & Lomb Optical Company.

(b) PTC was incorporated under the laws of the State of New York on September 15, 1983. It originally incorporated under the name of Criterion Corp.

4. Bausch & Lomb owns all of the shares of PTC, as set forth in No. 2 above.

5. The merger shall be effective on December 28, 2002.

6. The plan of merger was adopted by the Executive Committee of the Board of Directors of Bausch & Lomb on December 9, 2002.
