CONFIRMATORY ASSIGNMENT

WHEREAS, Assignor and Assignee wish by this document to confirm the previous acquisition of the Property (including the Trademark and URL) by Assignee in a document suitable for recording in the U.S. Patent and Trademark Office; and

WHEREAS, Assignor represents that it has never conveyed any of its rights, title or interests in the Property or in the Trademark or URL to any other party, except pursuant to the aforementioned Bill of Sale and Technology and Intellectual Property Sale and Assignment Agreement.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby confirms that it has assigned and transferred, and does hereby assign and transfer to Assignee, its successors and assigns, absolutely and forever, all of Assignor's right, title and interest in and to the Property (including the Trademark and the URL), together with the goodwill of the business symbolized by the Trademark and other intellectual property rights so assigned, and all causes of action for any and all past infringements of the rights so assigned occurring before or after the date of this assignment and the right to collect and retain the proceeds therefrom.

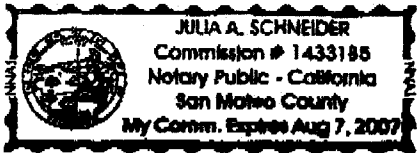


