## RELEASE OF SECURITY INTEREST

This Release of Security Interest (this "Release"), dated as of December 22, 2003, is made for the benefit of HPC Interactive, LLC (the "Company"), which was a signatory to an Asset Purchase Agreement and to an associated Intellectual Property Collateral Assignment & Security Agreement, both agreements between R.E. Ventures, Inc. ("R.E. Ventures") and the Company and both dated as of Nov. 15, 2002. Collectively, the two foregoing agreement are referred to herein as the "Agreements."

### RECITALS

A. The Company has entered into the Agreements, pursuant to which the Company has granted to R.E. Ventures a security interest ("Security Interest") in all of its right, title and interest in and to certain tangible and intangible assets of the Company set forth in the Agreements (the "Collateral"). The Collateral includes that certain trademark and associated domain name listed on Annex A attached hereto.

B. The Company performed its obligations under the Agreements without any breach thereof and the Company has satisfied in full all of its obligations under the Agreements.

NOW THEREFORE, R.E. Ventures hereby:

1. Releases and terminates (a) the Security Interest granted under the Agreements in and to all of the Collateral and (b) all other security interests granted by the Company or its affiliates to R.E. Ventures with respect to any assets of the Company or its affiliates.

2. Terminates the Agreements and hereby authorizes the Company or its designees (including any purchaser of the all or part of the Collateral) to take all actions such person or entity deems necessary or desirable to terminate any filings recording the security interests released herein, including (without limitation) filing UCC termination statements and filing this Release of Security Interest in the United States Patent and Trademark Office.
