WHEREAS, Assignee is desirous of acquiring all right, title and interest in and to said Trademark and Registration in the Territory;

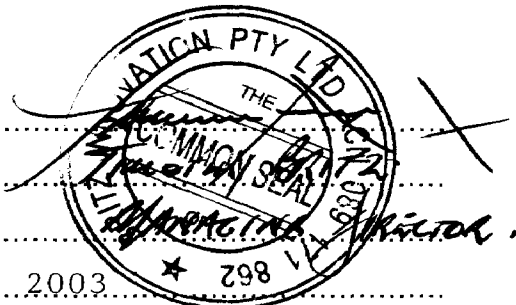
