ASSIGNMENT OF TRADEMARKS, SERVICE MARKS, NAMES AND DOMAIN NAMES

Assignor further covenants that Assignee will, upon its request, be provided promptly with all pertinent facts and documents relating to the Marks, will assist in the preparation and filing of all legal documents relating thereto, will facilitate the legal transfer of all domains through the appropriate registrar, will testify as to the same in any interference, opposition, cancellation or proceeding related thereto, and will promptly execute and deliver to Assignee or its legal representatives any and all papers, instruments or affidavits required to apply for, obtain, issue and enforce any such Marks which may be necessary or desirable to carry out the purposes thereof.
