Further, Assignor hereby assigns all of its right, title and interest in any other trademarks, service marks, trade names and other trade identities used in the Assignee's business but not listed on Exhibit A attached hereto and agrees to execute any additional documentation reasonably required to effectuate this Trademark Assignment.

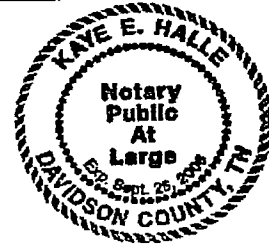
