TRADEMARK ASSIGNMENT

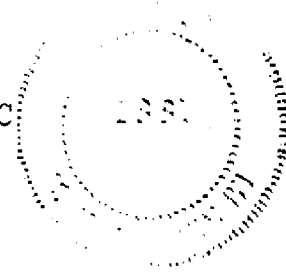
