## NUNC PRO TUNC ASSIGNMENT

On April 30, 1997, ZSI, Inc., a Michigan corporation, (hereinafter "ZSI") having its principal place of business prior to 1998 at 39074 Webb Court, Westland, Michigan 48185, caused to be filed in the United States Patent and Trademark Office the following United States Trademark Application, which issued as Registration No. 2,254,187 on June 15, 1999 (the "Trademark Application and Registration").


For good and valuable consideration to ZSI, the receipt of which is hereby acknowledged, ZSI hereby assigns as of January 6, 1998 and does assign unto HORIZON, its successors, legal representatives and assigns, whatever right, title, and interest ZSI had throughout the world in the Trademark Application and Registration, and all Trademarks which may be registered thereon, and all rights of priority under International Conventions and applications for trademarks which may be filed for the Trademark Application and Registration in any country or countries foreign to the United States.

ZSI hereby assigns as of January 6, 1998 and does assign to HORIZON, its successors, legal representatives, and assigns, all claims for damages and all remedies arising out of any infringement of the Trademark Application and Registration which may have accrued or may accrue, including, but not limited to, the right to sue for and collect damages for past infringements of the Trademark Application and Registration.

ZSI agrees that, at HORIZON's request, it will communicate to HORIZON, its successors, legal representatives, and assigns, any fact known to ZSI respecting the Trademark Application and Registration immediately upon becoming aware of those facts, that it will testify in any legal proceeding involving the Trademark Application and Registration that it will sign all lawful papers, and that it will generally do everything possible, at no out-of-pocket expense to ZSI, to aid HORIZON, its successor, legal representatives and assign, to obtain and enforce the Trademark Application and Registration in all countries.
