**PARTIAL RELEASE OF
DOMESTIC TRADEMARK SECURITY AGREEMENT**

This PARTIAL RELEASE OF DOMESTIC SECURITY AGREEMENT ("Partial Release") is made as of the 18th day of July, 2003, by and between BANK OF AMERICA, N.A., a national banking association, as Lender and Releasing Party, having an office located at 231 South LaSalle Street, Chicago, Illinois 60697 ("Lender") and THE JEL SERT CO., an Illinois corporation, a Borrower and Receiving Party, having an office at Highway 59 & Conde Street, Chicago, Illinois 60185 ("Borrower")

WITNESSETH

WHEREAS, Lender and the Borrower are parties to a certain Domestic Trademark Security Agreement of December 15, 2000 wherein Borrower granted Lender a security interest in its trademarks, include those trademarks listed on Exhibit A, attached hereto;

WHEREAS, Lender desires to grant to Borrower a partial release of the Domestic Trademark Security Agreement, as to the trademarks specifically listed on Exhibit A.
