(Under Section 805 of the Business Corporation Law  
of the State of New York)

Pursuant to the provisions of Section 805 of the Business Corporation Law of the State of New York, the undersigned, Stephen Schuster and Shunsuke Nishimura, being respectively the President and Secretary of KONICA GRAPHIC IMAGING INTERNATIONAL, INC., hereby certify that:

FIRST: The name of the corporation is KONICA GRAPHIC IMAGING INTERNATIONAL, INC. The corporation was originally formed under the names Powers Photo Engraving Company and was also formerly known as Powers Chemco, Inc., Chemco Technologies, Inc., and Konica Imaging U.S.A., Inc.

SECOND: The Certificate of Incorporation of the corporation was filed by the Department of State on October 31, 1904.

THIRD: The Certificate of Incorporation is hereby amended or changed to effect a change of name from KONICA GRAPHIC IMAGING INTERNATIONAL, INC. by changing Article FIRST thereof so that, as amended, said Article shall be and read as follows:

"FIRST: The name of the corporation is:

KONICA MINOLTA GRAPHIC IMAGING U.S.A., INC."

FOURTH: The Amendment was authorized by the affirmative vote of a majority of the Board of Directors, followed by the unanimous written consent of the holders of all the outstanding shares entitled to vote thereon.
