TRADEMARK ASSIGNMENT

WHEREAS, STAUFFER SEEDS, INC., a Texas Corporation having its principal offices at 9802 Nicholas Street, Suite 320, Omaha, NE 68114 (“Assignor”), has adopted and used in its business the following trademarks (the “Marks,” described in the attached as Annex I):

1. S and DESIGN, which is registered in the United States Patent and Trademark Office under Registration No. 2,011,821, issued October 29, 1996 for natural agricultural products; and
2. STAUFFER SEEDS – a common law word mark; and
3. STAUFFER SEEDS and DESIGN – a common law design mark;

WHEREAS, LAWHON MIDWEST LLC, an Arkansas corporation having its principal offices at 522 Poplar, McCrory, AR 72101 (“Assignee”) is desirous of acquiring said Marks and said registration(s) therefor;

NOW, THEREFORE, for good and valuable consideration - the receipt and sufficiency of which is hereby acknowledged - STAUFFER SEEDS, INC. does hereby sell and assign unto LAWHON MIDWEST LLC all right, title and interest in and to the Marks and the registration therefor, No. 2,011,821, together with the goodwill of the business symbolized by the Marks; all variants thereof; all subsidiary rights in and to the Marks, including any applications or resulting registrations for the Marks, including future variants of same; the right to secure renewals therefor; the right to any accrued causes of action; and the right to recover and have damages and profits for past infringement, if any.

Assignor hereby represents, covenants and warrants that it has the exclusive right to grant, transfer, assign and convey the Marks and the accompanying goodwill; that such conveyance will not violate the rights of any third parties; that the Marks are not subject to any encumbrances or liens of any kind; and that Assignor believes to the best of its knowledge that its use of said Marks does not presently infringe upon the rights of any third parties, and that Assignee’s use of the same will not infringe upon any third party rights.

Assignor hereby indemnifies and agrees to hold Assignee harmless against any loss, damage or liability - including any costs, attorney’s fees and expenses - which may arise out of or occur as a result of any actions, suits, claims or demands which may be brought against Assignee by virtue of the rights transferred under this Agreement.

Assignor agrees to furnish Assignee with documents supporting the Assignor's claimed dates of first use of the mark and those supporting actual use in trade on specific goods, as well as copies of all files relating to the adoption, use, registration and protection of the mark.

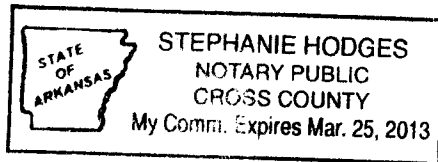
