## ASSIGNMENT OF TRADEMARK

Assignor acknowledges that no right to the Assigned Trademark, its registrations or its applications, is retained by the Assignor or conveyed to any party other than Assignee. Assignor agrees to take all actions and to cooperate as may be reasonably necessary or desirable to complete the transfer of the Assigned Trademark or to complete any pending application for the Assigned Trademark, including but not limited to by execution of any documents reasonably necessary or desirable in connection therewith.

This Assignment and the rights and obligations hereunder shall be binding upon and inure to the benefit of the parties hereto and their respective heirs, legal representatives, successors and assigns.

This Assignment may be executed in multiple counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument.

This Assignment shall be governed by the trademark law of the jurisdiction in which each registration or registration application was filed, as appropriate, but shall be otherwise governed and construed in accordance with the laws of the State of Colorado, without regard to principles of conflicts of law.

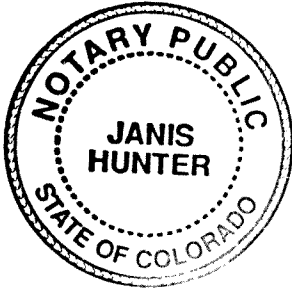
