## **TRADEMARK ASSIGNMENT OF SECURITY**

WHEREAS Stolle Machinery Company, LLC, a limited liability company formed under the laws of Delaware, located at 6949 S. WHEREAS, pursuant to the Agreements, Borrower is granting to Agent for its benefit and for the ratable benefit of Lenders a security interest in the Marks, the goodwill of the business symbolized by the Marks, and the registrations and applications therefor.



Borrower expressly acknowledges and affirms that the rights and remedies of Agent and Lenders with respect to the assignment and security interest granted hereby are more fully set forth in the Agreements.






