## U.S. TRADEMARKS RELEASE OF SECURITY INTEREST

Reference is made to the Amended and Restated Security Agreement dated as of December 3, 1998, as amended and restated as of May 31, 2001 (the "Security Agreement"), among TransDigm Holding Company, TransDigm Inc.
