



This agreement is made and entered into on the present 28th day of October 2002

BETWEEN:

- (1) YVES SAINT LAURENT FRANCE B.V. with its registered address at Amstelplein 1 – Rembrandttoren 13 HG – 1096 HA – Amsterdam, and its place of effective management located in France – 7 avenue George V – 75008 Paris (hereinafter referred to as the "Assignor"); and
- (2) LUXURY GOODS INTERNATIONAL (L.G.I.) S.A. with its registered address at Via Industria, 6814 Cadempino, Switzerland (hereinafter referred to as the "Assignee");

WHEREAS:

- (A) Yves Saint Laurent is the originator and creator of a line of fashion products internationally known to the public because they are characterised by the highest possible level of quality and taste.
- (B) Pursuant to the Issuance of Shares in the Capital of Yves Saint Laurent France B.V. against a Contribution in Kind dated December 28th, 2001 and executed by deed of Steven Perrick, civil law notary officiating in Amsterdam, attached to present Agreement as Annex I, the Assignor legally and beneficially holds in its own name and for its own exclusive account:
- the full legal and beneficial ownership of the Yves Saint Laurent trademarks and variations thereof covering all products and services, except Fragrances and Cosmetics, for the United States of America, its territories and possessions, and Venezuela and Benelux as listed in Annex 2 and as limited by the license right (hereinafter the "License to Yves Saint Laurent Fashion AG") granted under the License agreement entered into with Yves Saint Laurent Fashion AG on the 1st day of July 1987 and by the other license and sublicense rights listed in Annex 3 to the present Agreement;
 - the sole and exclusive right to use and license the use of the Yves Saint Laurent trademarks and variations thereof covering all products and services, except Fragrances and Cosmetics, for the territory of Australia and Canada, as acquired pursuant to the License agreement (hereinafter the "License") entered into with Yves Saint Laurent International BV (hereinafter the "Licensor") on the 1st day of July 1987, as limited by the license right (hereinafter the "Sub-License to Yves Saint Laurent Fashion AG") granted under the License agreement entered into with Yves Saint Laurent Fashion AG on the 1st day of July 1987 and by the other license and sublicense rights listed in Annex 3 to the present Agreement,

hereinafter jointly referred to as the YVES SAINT LAURENT Intellectual Property and Rights.

- (C) The Assignor wishes to assign to the Assignee and the Assignee wishes to receive from Assignor the YVES SAINT LAURENT Intellectual Property and Rights, for a consideration of Euro 65.000.000 (sixty five million).

IT IS AGREED as follows.

1. INTERPRETATION

- 1.1 The Recitals and Schedules hereto are considered part of the Agreement.

"YVES SAINT LAURENT Creations and Products" means all drawings, sketches, drafts, models, computer software, prototypes and final products created in any colour or materials or devised by the Assignor, or employees of the Assignor or otherwise by or on behalf of the Assignor, at all stages of development and produced in connection with the activities and pertinent to the core of the YVES SAINT LAURENT Business;

"YVES SAINT LAURENT Business" means all activity of creating, developing and selling YVES SAINT LAURENT products.

"YVES SAINT LAURENT Intellectual Property and Rights" has the meaning indicated in Whereas B above;

"YVES SAINT LAURENT Image" means the public acceptance of, and the good will associated with, YVES SAINT LAURENT 's international reputation in the luxury fashion goods industry especially for luxury leather goods identified by the YVES SAINT LAURENT Trade Marks which has been developed through the expenditure of time, effort and money on product research and development, the design of the YVES SAINT LAURENT Boutiques, and through many years of experience in such industry, YVES SAINT LAURENT has acquired expertise and knowledge with respect to the standardisation of the merchandising, promotion, distribution and sale of products, merchandise and items bearing the YVES SAINT LAURENT Trade Mark.

"Gucci" means any sole proprietorship, partnership, corporation, joint venture, association, joint stock company, trust, unincorporated organisation or other business entity that directly, or indirectly through one or more intermediaries, is controlled by, or is under common control with, Gucci Group N.V., a public limited liability company organised and existing under the laws of Netherlands.

"Licensed Products" means YVES SAINT LAURENT products manufactured or distributed by Authorised Suppliers under a license agreement with the Assignor and its Licensees.

- 1.2 The Annexes hereto form part of and are incorporated in this Agreement.

2. COVENANTS FROM THE ASSIGNOR

- 2.1 Annex 2 sets forth an accurate and complete list of all trademarks (registered or unregistered), trademark applications, service marks, service mark applications, service mark applications, assumed names and trade

There are no adverse claims or demands of any person pertaining to any of the Trade Marks and, to the best knowledge of the Assignor, there is no valid basis for any such claim.

- 2.2. The License is valid, binding and enforceable. It attributes to the Assignor all the rights and powers therein specified.
- 2.3. The use or other exploitation of the Trade Marks and of the License by the Assignor do not infringe on or dilute the rights of any other person.

3. ASSIGNMENT

- 3.1. Subject to the provisions of this clause and effective on the present ___th day of October 2002, the Assignor assigns to the Assignee with full title guarantee:
 - 3.1.1. all right, title and interest in the YVES SAINT LAURENT Intellectual Property and Rights that it owns and are existing at the date of this Agreement, including all statutory and common law rights attaching thereto and the right to sue for past infringements and to retain any damages obtained as a result of such action;
 - 3.1.2. by present assignment of future rights, all right, title and interest in the copyright and design right in any YVES SAINT LAURENT Intellectual Property and Rights that it shall own which arises after the date of this Agreement, including all statutory and common law rights attaching thereto, with the intent that immediately on the creation of such rights the copyright and design right shall vest in the Assignee.
- 3.2. The Assignor agree to assign with full title guarantee to the Assignee upon creation, all YVES SAINT LAURENT Intellectual Property and Rights that is created after the date of this Agreement and that the Assignor shall own (including copyright and design right).
- 3.3. The parties agree that the Assignee shall use or authorise the use of the Trade Marks in all areas, without the Assignor prior written consent.
- 3.4. The parties shall cause to be taken all reasonably necessary and appropriate steps (i) to protect the Trade Marks and (ii) to maintain the prestige of the YVES SAINT LAURENT Image and Trade Marks in the business of the Assignee, including manufacturing, distribution, advertising, marketing and publicity. The costs associated with protecting and maintaining the YVES SAINT LAURENT Trade Marks shall be borne by the Assignee.
- 3.5. Save as expressly provided for the remuneration in paragraph 4, no royalty will be payable to the Assignor or any third party by the Assignee for the exploitation and use of the YVES SAINT LAURENT Intellectual Property and Rights.
- 3.6. For the avoidance of doubt the Assignor provides no undertakings in respect of the use or validity of the Trade Marks in respect of goods or services which fall outside the goods or services for which the Trade Marks are registered.
- 3.7. The Assignor warrants that the execution of this Agreement shall vest in the Assignee all Intellectual Property Rights in the YVES SAINT LAURENT **TRADEMARK** Intellectual Property and Rights and the Assignor shall indemnify the Assignee for any and all claims, damages, costs and expenses, including reasonable attorneys' fees, that the Assignee may incur in connection with the execution of this Agreement.

- 3.8. The Assignor hereby waives its right to be identified as the author of the Creations and its/her right to object to the derogatory treatment of the Creations. This waiver is made expressly in favour of the Assignee and shall extend to all successors in title to the Intellectual Property Rights in the Creations.
- 3.9. Effective on the present ___th day of October 2002, Assignor does hereby absolutely, unconditionally and irrevocably, grant, transfer, bargain, sell, assign, convey, and set over unto Assignee, its successors and assigns, the quality of licensee under the License, which shall hereinafter be for the exclusive account and interest of the Assignee, and all of the rights, title, interest, powers, earnings, income, profits, benefits and advantages arising from the License to the licensee thereunder.
- 3.10. The Assignee herewith accepts to acquire, effective on the present ___th day of October 2002, the quality of licensee under the License and to undertake all the obligations, duties, guarantees, charges, liabilities and promises which the License provides as laying upon the licensee thereunder. The Assignor is herewith discharged from those obligations, duties, guarantees, charges, liabilities and promises.

4. CONSIDERATION

- 4.1 The Assignee hereby agrees to pay to the Assignor the amount of Euro 65.000.000 (sixty five million) for the assignment and transfer of the YVES SAINT LAURENT Intellectual Property and Rights.
- 4.2 The consideration shall be paid within 90 days from the execution of this agreement. For each day subsequent to the present 28th day of October 2002, the Purchase Price receivable, to the extent not yet fulfilled by the Purchaser under the terms of the present Agreement, or otherwise extinguished, will bear interest at a rate equal to the one month Euribor on EURO current on the present 28th day of October 2002, increased of 12,5 basis points (the "Interest"). The Interest will accrue for every day the Purchase Price receivable is, totally or partially, still outstanding subsequent to the present 28th day of October 2002. The Interest will be liquidated and it will fall due by the Purchaser in monthly instalments starting on the present 28th day of October 2002.

5. FURTHER ASSURANCE

The Assignor shall sign any documents and do any other acts and procure the signing of any documents and the doing of other acts as may be necessary formally to give effect to the provisions of this Agreement and render such assistance as the Assignee may reasonably require to obtain appropriate protection for any of the YVES SAINT LAURENT Intellectual Property and Rights anywhere in the world at the Assignees' expense.

9. PROVISIONS SEVERABLE AND PARTIAL INVALIDITY



10. GOVERNING LAW


