TERMINATION OF SECURITY INTEREST

Nordea Bank Norge ASA, Reg, no. WHEREAS MediaBin has satisfied the terms and conditions of the Overdraft Facility Agreement and the terms and conditions pursuant to the Promissory Note.


NOW THEREFORE, the Bank hereby terminates the Security Interest granted by the Overdraft Facility Agreement.
