ASSIGNMENT OF TRADEMARKS

Recitals

WHEREAS, pursuant to The Malathion and Methyl Parathion Asset Purchase Agreement dated November 25, 2003 between Cheminova A/S (“Cheminova”), a Denmark Corporation, and Griffin L.L.C. (“Griffin”) a Delaware Limited Liability Company, Cheminova purchased the malathion and methyl parathion assets of Griffin set forth in that agreement, including all of Griffin’s trademarks, trademark applications, patents, and patent applications principally and directly related to malathion and methyl parathion (identified in Exhibit 1 of the Asset Purchase Agreement).

WHEREAS, under the aforementioned Agreement, Cheminova paid Griffin consideration of nine million and four hundred and fifty thousand U.S. dollars (U.S. \$9.450 million).

Assignments

Now, for valuable consideration, the receipt of which is acknowledged by Griffin:

1. Griffin and its former affiliate Griffin Corporation of Valdosta, Georgia (“Griffin Corp.”), respectively, hereby assign, together with the goodwill of the businesses in connection with which such marks are used, their entire respective interest in the following trademarks, which have been adopted and used by Griffin in its malathion and methyl parathion businesses and registered with the United States Patent and Trademark Office.

a. Trademark Registration No. 2,337,348 (owned by Griffin L.L.C.) pertaining to Griffin’s “Atrapa” insecticide products which contain the active ingredient malathion.

b. Trademark Registration No. 2,226,736 (owned by Griffin Corp.) pertaining to Griffin’s “Declare” insecticide products which contain the active ingredient methyl parathion.

2. Griffin and Griffin Corp., respectively, represent and warrant that they have not granted and will not grant any rights inconsistent with the rights granted herein, and hereby bind

themselves, and their legal representatives and assigns, to execute all documents and perform all acts which may be necessary to carry these assignments into full effect including the recording of this Assignment with the United States Patent and Trademark Office.
