LICENSE AND ASSIGNMENT AGREEMENT

This Agreement (the "Agreement") dated April 15, 2002 (the "Effective Date") is by and between Colgate-Palmolive Company ("Colgate"), a Delaware corporation with offices at 300 Park Avenue, New York, New York 10022, and Brian L. Wilk, D.M.D., a United States citizen domiciled at 1433 Catlin Way, Dresher, Pennsylvania 19025 ("Dr. Wilk").

WHEREAS, Dr. Wilk has common law rights to the mark SIMPLY WHITE (the "Mark") and has applied to register the Mark with the U.S. Patent and Trademark Office under Serial No. 75/624,163;

WHEREAS, Colgate wishes to use the Mark and have the option to purchase the Mark; and

WHEREAS, Dr. Wilk is willing to license and sell the Mark to Colgate under the terms and conditions set forth in this Agreement.

In consideration for the foregoing, the covenants hereinafter set forth, the mutual obligations described below, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Dr. Wilk and Colgate hereby agree as follows.

1. Assignment.

- (a) Dr. Wilk hereby assigns to Colgate all of his common law rights to the Mark.

2. License.

- (a) Dr. Wilk hereby grants to Colgate an exclusive, perpetual license to use the Mark on and in connection with the development, manufacturing, marketing, promotion, offering and sale of any products anywhere in the world to the full extent of Dr. Wilk's rights in the Mark.

- (c) During the term of this Agreement, Dr. Wilk will not license or assign the Mark to any third party.

(d) Dr. Wilk hereby agrees that he will not at any time use a mark similar to, including, but not limited to, marks that are confusingly similar to the Mark on any goods or services.

(e) Colgate may freely sub-license and/or assign the rights granted in this Agreement.

4. Option to Purchase Mark.

(a) Dr. Wilk hereby grants to Colgate an exclusive option to purchase the application Serial No. 75/624,163; or any registration that results from this application, at whatever time it wishes for one U.S. dollar (\$1.00).


