**CERTIFICATE OF AMENDMENT  
TO  
CERTIFICATE OF INCORPORATION  
OF  
UTILITY AUTOMATION INTEGRATORS, INCORPORATED**

UTILITY AUTOMATION INTEGRATORS, INCORPORATED, a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware, does hereby certify:

**FIRST:** That the Board of Directors of said corporation, by unanimous consent pursuant to Section 141(f) of the General Corporation Law of the State of Delaware, has adopted a resolution proposing and declaring advisable the following amendment to the Certificate of Incorporation of said Corporation:

Article 1 of the Certificate of Incorporation shall be deleted in its entirety, and the following shall be substituted in lieu thereof:

**ARTICLE 1  
NAME OF CORPORATION**

The name of the Corporation shall be UAI, Inc., and any and all references to Utility Automation Integrators, Incorporated shall hereafter be deemed to refer to UAI, Inc.


**SECOND:** That in lieu of a meeting and vote of the shareholders, the shareholders have given unanimously consent to said amendment in accordance with the provisions of Section 228(a) of the General Corporation Law of the State of Delaware.

**THIRD:** That the aforesaid amendment was duly adopted in accordance with the applicable provisions of Sections 242, 141(f) and 228 of the General Corporation Law of the State of Delaware.

**FOURTH:** That the aforesaid amendment shall not be effective until January 1, 2004.
