GRANT OF SECURITY INTEREST IN
UNITED STATES TRADEMARKS

FOR GOOD AND VALUABLE CONSIDERATION, receipt and sufficiency of which are hereby acknowledged, **Vantico A&T US Inc.**, a Delaware corporation (the "Grantor") with principal offices at 4917 Dawn Avenue, East Lansing, MI 48823, hereby bargains, sells, conveys, assigns, sets over mortgages, pledges, hypothecates and transfers to Deutsche Bank AG, New York Branch, as Collateral Agent, with principal offices at 90 Hudson Street, 5th Floor, Jersey City, New Jersey 07302 (the "Grantee"), and its successors and assigns, for the ratable benefit of the Secured Creditors (as defined in the Security Agreement referred to below), a first priority security interest in (i) all of the Grantor's right, title and interest in, to and under the United States trademarks, trademark registrations and trademark applications (the "Marks") set forth on Schedule A attached hereto, (ii) all Proceeds (as such term is defined in the Security Agreement referred to below) of the Marks, including all causes of action for past, present and future infringement or dilution of any of the Marks and (iii) the goodwill of the businesses associated with or symbolized by the Marks.


