



TRADEMARK ASSIGNMENT AGREEMENT

WHEREAS, Assignee is desirous of acquiring said Marks and the registration thereof;


NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Parties agree as follows:






