## AMENDMENT TO AMENDED AND RESTATED PATENT, TRADEMARK AND COPYRIGHT SECURITY AGREEMENT

This Amendment to Amended and Restated Patent, Trademark and Copyright Security Agreement (the "Amendment"), dated as of April 11, 2003, is entered into by and between MOBILITY TECHNOLOGIES, INC., a Delaware corporation (formerly named "Traffic.com, Inc.") (the "Grantor"), and POTOMAC ASSET MANAGEMENT COMPANY, INC., as Agent for the Lenders referred to below (the "Secured Party"). Unless otherwise defined herein, capitalized terms used herein shall have the meanings ascribed to them in the Credit Agreement (as defined below).

WHEREAS, pursuant to a certain Amended and Restated Credit Agreement dated March 29, 2002 by and among Grantor, PNC Bank, National Association ("PNC"), as agent, and certain lenders signatory thereto (the "Restated Credit Agreement"), certain lenders provided Grantor with a \$20,000,000 loan facility for working capital purposes;

WHEREAS, Grantor and PNC entered into an Amended and Restated Patent, Trademark and Copyright Security Agreement dated March 29, 2002 (the "IP Security Agreement") to provide additional security for the repayment of indebtedness under the Restated Credit Agreement;

WHEREAS, pursuant to a certain Amendment to Amended and Restated Credit Agreement dated April 23, 2002 by and among Grantor, PNC, as agent, and lenders signatory thereto (the "Credit Agreement Amendment" and together with the Restated Credit Agreement, the "Existing Credit Agreement"), the parties thereto agreed to certain amendments to the terms of the Restated Credit Agreement;

WHEREAS, PNC resigned as agent, and Secured Party was appointed as successor agent pursuant to the terms of the Existing Credit Agreement;

WHEREAS, pursuant to a certain Consent and Second Amendment to Amended and Restated Credit Agreement dated April 11, 2003 by and among Grantor, Secured Party, as agent, and lenders signatory thereto (the "Second Credit Agreement Amendment", and together with the Restated Credit Agreement and the Credit Agreement Amendment, the "Credit Agreement"), the parties thereto agreed to certain amendments to the terms of the Existing Credit Agreement; and.

WHEREAS, Grantor and Secured Party desire to acknowledge and agree that the IP Security Agreement, and the liens, security interests and guarantees granted and issued thereunder, secure and guaranty the Obligations of Grantor under the Credit Agreement and that Schedule A to the IP Security Agreement shall be amended to include additional patents, patent applications, trademark applications, registered and unregistered trademarks, registered and unregistered copyrights or copyright applications, domain names.

NOW, THEREFORE, intending to be legally bound hereby, the parties hereto agree as follows:

- 1. All references in the IP Security Agreement to "Obligations" under the Existing Credit Agreement shall be deemed to refer to the "Obligations" pursuant to and as defined in the Credit Agreement. All references in the IP Security Agreement to the "Credit Agreement" shall be deemed to refer to the Credit Agreement.
- 2. Schedule A to the IP Security Agreement shall be replaced with Schedule A attached hereto (the "New Schedule A"), and all references in the IP Security Agreement to "Schedule A" shall be deemed to refer to the New Schedule A.
- 3. This Amendment shall be binding upon Grantor and upon its successors and assigns and shall inure to the benefit of Secured Party and the Lenders and their respective successors and assigns; all references herein to Grantor shall be deemed to include its successors and assigns. The successors and assigns of such entities shall include, without limitation, their respective receivers, trustees, or debtors-in-possession.
- 4. Grantor hereby agrees from time to time, as and when requested by Secured Party or any Lender to execute and deliver or cause to be executed and delivered, all such documents, instruments and agreements and to take or cause to be taken such further or other action as Secured Party or such Lender may reasonably deem necessary or desirable in order to carry out the intent and purposes of this Amendment and the Loan Documents.
- 5. This Amendment shall be governed by and construed in accordance with the laws of the Commonwealth of Pennsylvania applied to contracts to be performed wholly within the Commonwealth of Pennsylvania.
- 6. This Amendment may be executed in two or more counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument.
- 7. Wherever possible, each provision of this Amendment shall be interpreted in such manner as to be effective and valid under applicable law, but if any provision of this Amendment shall be prohibited by or invalid under such law, such provision shall be ineffective to the extent of such prohibition or invalidity without invalidating the remainder of such provision or the remaining provisions of this Amendment.
