ASSIGNMENT OF TRADEMARK RIGHTS

THIS ASSIGNMENT OF TRADEMARK RIGHTS ("Assignment"), is effective as of the 24th day of April 2002 ("Effective Date"), by and between SIND, LLC, a Delaware Limited Liability Company ("Assignor") and SI Corporation, a Delaware corporation ("Assignee").

WHEREAS, Assignor is the owner of the entire right, title and interest in the mark EARTHSCAPE, and its associated United States Trademark Registration No. 2,116,035 registered November 25, 1997, for "synthetic fabric for weed growth prevention, erosion control, soil stability and retention, and moisture retention and improvement of the appearance of landscapes" in International Class 19 (hereinafter "the Trademark");

WHEREAS, Assignor desires to transfer to Assignee all of its right, title and interest in and to the Trademark; and

WHEREAS, Assignee desires to accept the Trademark and intends to continue to use of the Trademark in commerce and in interstate commerce on or in connection with the goods.

NOW, THEREFORE, to all whom it may concern:

Be it known that for good and valuable consideration, the receipt and adequacy of which is hereby expressly acknowledged, Assignor has sold, assigned and transferred, and does hereby sell assign, assign and transfer to Assignee, and its successors and assigns, the entire right, title and interest in and to said Trademark and registration therefor, and any renewals thereof, together with the goodwill of the business symbolized by said Trademark and the registration thereof, as well as all claims for damages or profits by reason of past infringement of said Trademark, the application and the registration therefor, and the right to sue for and collect the same.
