**RELEASE OF SECURITY INTEREST IN  
INTELLECTUAL PROPERTY**

This Release of Security Interest in Intellectual Property ("Release") is made as of July 1, 2003 by Comerica Bank, as successor in interest to Imperial Bank ("Secured Party"), in favor of Randall International, LLC a California limited liability company, with an address at 2885 Loker Avenue East, Carlsbad, California 92008 ("Company").

WHEREAS, Company executed that certain Commercial Security Agreement dated January 2, 2001, ("Security Agreement"), pursuant to which Company granted a security interest to Secured Party in, among other things, certain intellectual property owned by Company to secure certain debt obligations of the Corporation to Secured Party (the "Debt");

WHEREAS, Company executed that certain Memorandum of Security Agreement in Trademark dated June 6, 2000 ("Trademark Agreement"), pursuant to which Company granted a security interest to Secured Party in certain trademarks as identified on Schedule A attached hereto (the "Collateral");

WHEREAS, said Trademark Agreement was filed with the Assignment Branch of the United States Patent and Trademark Office on June 29, 2000 and recorded at Reel/Frame: 002110/0030; and

WHEREAS, the Debt has been satisfied in full and Secured Party has agreed to release all liens and interests granted under the Trademark Agreement.


NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the parties agree as follows:

1. Secured Party releases, without recourse or warranty, and reconveys to Company, all liens and interests granted under the Trademark Agreement.
2. Secured Party hereby represents and warrants that it has not transferred any rights in the Collateral to any other party.
3. This Release may be executed in two counterparts, each of which shall be deemed to be an original, and all such counterparts shall constitute but one and the same instrument.

4. Secured Party shall execute and deliver all other instruments and documents and take all other actions as may be reasonably required or appropriate to carry out the purposes of this Agreement. Notwithstanding the foregoing, the Company shall be responsible for recording this Release with the United States Patent and Trademark Office.
