

ARTICLES OF AMENDMENT TO
ARTICLES OF INCORPORATION
OF
LONE STAR SCREW COMPANY OF HOUSTON, INC.

Pursuant to the provisions of Article 4.04 of the Texas Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Article of Incorporation:

ARTICLE ONE

The name of the corporation is Lone Star Screw Company of Houston, Inc.

ARTICLE TWO

The following amendment to the Articles of Incorporation was adopted by the shareholders of the corporation on June 01, 1993, changing the name of the corporation. The amendment paragraph within this section of the amendment alters or changes Article One of the original Articles of Incorporation and full text of each provision altered is as follows:

The name of the corporation is ISS-Lone Star-Houston, Inc.

ARTICLE THREE

The number of shares of the corporation outstanding at the time of such adoption was 100; and the number of shares entitled to vote was 100.

ARTICLE FOUR

The holders of all of the shares outstanding and entitled to vote on said amendment have signed a consent in writing pursuant to Article 9.10 adopting said amendment and any written notice required by Article 9.10 has been given.


