ASSIGNMENT OF TRADEMARK

This Assignment of Trademark dated as of the 17th day of October, 2002 by and between Ironwood Gourmet, Inc. (successor-in-interest by assignment from Ironwood Grillware, Inc.) located at 3704A Alliance Drive, Greensboro, North Carolina 27407 (hereinafter the "Assignor") and Fox Run USA, LLC, located at Plaza One, Park 80 West, Saddle Brook, New Jersey 07663 (hereinafter the "Assignee").

RECITALS

WHEREAS, Assignor has been using the mark "Ironwood Gourmet" in connection with wooden tableware, namely cutting boards, steak plates and salad bowls in international Class 21 (hereinafter the "Mark");

WHEREAS, in connection with said Mark the Assignor has filed in the United States Patent and Trademark Office Application Serial Number 76/275197 on June 25, 2001 (hereinafter the "Trademark Application");

WHEREAS, the Assignor has alleged a date of first use in interstate commerce of November 5, 2001;

WHEREAS, a Notice of Allowance has been issued with respect to the Application and a Notice of Acceptance of Amendment to Use has been issued as of July 22, 2002;

WHEREAS, the Application has been approved for publication but has not been published;

WHEREAS, the Assignee is acquiring the entire business or portion thereof from Assignor to which the Mark pertains;

WITNESSETH:

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Assignor does hereby assign to Assignee all of its right, title and interest in and to the Mark as well as all pending applications and registrations relating thereto, including the Application above identified, all of which are hereinafter enumerated and identified in detail on Schedule "1" attached hereto, and further hereby covenants that it has the full right to convey the entire right, title and interest in the Mark herein assigned to the Assignee.

AND, FURTHER, Assignor hereby covenants and agrees that it will communicate to said Assignee, or Assignee's successors, assigns and legal representatives, all facts known to it pertaining to said trademark and testify in all legal proceedings, sign all lawful papers, execute all documents

required to confirm the registration of the Mark, make all rightful oaths, and in general perform all lawful acts necessary or proper to aid said Assignee, its successors, and legal representatives or nominees in obtaining and enforcing lawful trademark protection for the Mark, in any and all countries.

AND, FURTHER, the Assignor hereby covenants and represents that it has received no notice, nor is it otherwise aware of any claims of trademark infringement with respect to the Mark and the Assignor understands that the Assignee is relying upon this representation in connection with its purchase of the Assignor's business, and Assignor agrees to indemnify and save harmless Assignee from all infringement claims arising from the use of said Mark.

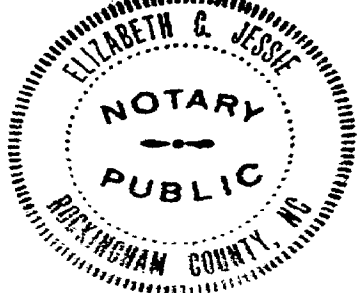
