ARTICLES OF MERGER

The undersigned General and Limited Partners of the ~~surviving entity in a~~ merger pursuant to Section 92A.120 of the Nevada Revised Statutes, and Section 2.11 of the Texas Limited Partnership Act hereby submit the following Articles of Merger in accordance with Nevada and Texas law.
