TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT (the "Assignment") is made as of this 30 day of July, 2001, by and between Thomas Trademark Holding BV ("Assignor") and Megargy Licencia Hasznosító Korlátolt Felelősségű Társaság ("Assignee").

WHEREAS, Assignor and the ultimate parent of Assignee ("Parent") are parties to a Stock and Asset Purchase Agreement, pursuant to which Assignor has agreed to transfer to a wholly owned subsidiary of Parent and Assignee has agreed to acquire certain Company Intellectual Property (as defined in Section 3.08 of the Stock and Asset Purchase Agreement), including, without limitation, the United States trademark registrations and applications identified and set forth on Schedule A attached hereto and incorporated herewith (collectively, the "Marks"), and the goodwill associated therewith; and

WHEREAS, Assignee wishes to acquire Assignor's entire right, title and interest in and to the Marks, together with the goodwill in connection with which the Marks are used;

NOW THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, Assignor does hereby transfer and assign to Assignee all the right, title and interest Assignor has or may have in the Marks and in any and all other marks or names owned or used by the Assignor or in which Assignor otherwise has any ownership interest, including any rights under common law, and which include the listed terms of said Marks alone or in combination with other words, figures, designs or indicia, including any rights, title and interest as service marks, trademarks, trade names and all common law rights connected therewith, together with the goodwill with respect to which the Marks or any such other marks or names have been used and/or registered and any and all licenses together with all royalties or payments thereto, and all claims and causes of action relating to infringement of said Marks or said other marks or name.

Assignor will assist in obtaining or providing any further documents which may be required to effect this transfer in the United States or confirm chain or title thereto.

This Assignment may be assigned in counterparts, each of which shall be deemed an original, but together shall constitute a single instrument.


