Koppers Industries, Inc., a corporation organized and existing under the laws of the Commonwealth of Pennsylvania (hereafter "ASSIGNOR"), having its principal office and place of business at 436 Seventh Avenue, Pittsburgh, Pennsylvania 15219, is the sole and exclusive owner of the trademarks, registrations and applications therefor on the Principal Register of the United States Patent and Trademark Office, together with the goodwill of the business symbolized thereby (hereafter, the "MARKS"), as identified on Schedule A, hereto.

Koppers Industries of Delaware, Inc., a corporation organized and existing under the laws of the State of Delaware, (hereafter "ASSIGNEE") having its principal office and place of business at 501 Silverside Road, Suite 67, Wilmington, Delaware 19809 is desirous of acquiring all right, title and interest in the MARKS.

Now, therefore, to all whom it may concern, be it known that for good and valuable consideration, the receipt and sufficiency thereof which is hereby acknowledged, said ASSIGNOR has assigned, transferred and set over, and does hereby assign, transfer and set over to ASSIGNEE the aforementioned MARKS, together with the goodwill of the business symbolized by said MARKS. The same to be held and enjoyed by ASSIGNEE for its own use and enjoyment, together with all claims by ASSIGNOR for damages or other relief, both at law and equity, by reason of past infringement of said MARKS, with the right to sue for, and collect

the same for its own use and benefit, and for the use and benefit of its successors, assigns or other legal representatives, as fully and entirely as the same would have been held and enjoyed by said ASSIGNOR if this assignment had not been made.

ASSIGNOR agrees that it will, by its officers, employees, legal representatives or other persons duly authorized, communicate to ASSIGNEE or the representatives thereof any facts known to it respecting said MARKS, and will, upon request, testify in any legal proceedings, sign all lawful papers, make all rightful oaths, and generally do all other and further lawful acts, deemed necessary or expedient by said ASSIGNEE or by counsel for ASSIGNEE, to assist or enable said ASSIGNEE to obtain and enforce full benefits of ownership of said MARKS and from the rights and interests herein assigned. ASSIGNOR additionally agrees to execute copies of this assignment or portions thereof regarding any or all of the aforementioned trademark, as required by ASSIGNEE in the future.

ASSIGNOR of the aforesaid MARK hereby agrees to waive all rights and privileges to attack the registration of any or all of the aforesaid MARK which ASSIGNOR has assigned as against any one claiming a right under any or all of the aforementioned MARK under ASSIGNOR's assignment or grant.

ASSIGNOR warrants that it is the sole and exclusive owner of the MARK listed within this agreement, and that the MARK is free of all liens, security interests, claims or other encumbrances except where specifically noted.
