ASSET PURCHASE AGREEMENT

THIS ASSET PURCHASE AGREEMENT (the "Agreement") is made and dated this 12th day of September, 2002, by and between CMA Business Credit Services, as assignee for the benefit of creditors of Rainbow Crane Company, LLC ("Seller"), and American Coua Merchandising, Inc. ("Buyer").

RECITALS

- A. On or about August 15, 2002 (the "Assignment Date"), Rainbow Crane Company, LLC ("Rainbow") executed a General Assignment for the benefit of creditors, as assignor, to Seller, as assignee (the "Assignment").
- B. Rainbow was engaged in the manufacturing and refurbishing of skill cranes.
- C. Seller and Buyer have agreed on the terms of a proposed acquisition by Buyer of the Assets, as defined below (the "Transaction").
- D. Seller and Buyer are entering into this Agreement to implement the Transaction, subject to and conditioned upon the terms set forth in this Agreement.

NOW, THEREFORE, in consideration of the mutual promises and covenants herein contained, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereto agree as follows.

Article I.

ASSET DESCRIPTION

- 1.01 **Assets.** Seller agrees that at the Closing it shall sell, assign, transfer and convey to Buyer and Buyer agrees that it shall purchase and acquire from Seller, all of Seller's right, title and interest in all of the assets owned, possessed, used or otherwise the property of or related to Rainbow, including the assets that are identified in pages 1-72 of Schedule 1.01 attached hereto (collectively, the "Assets"), except for the Excluded Assets, as defined in Section 1.02.
- 1.02 **Excluded Assets.** The Assets shall not include cash, cash equivalents, accounts receivable (except for the Receivables, as defined in Section 2.01 below), marketable and unmarketable securities, life insurance contracts, insurance refunds, tax refunds, security and utility deposits, causes of actions against third parties, interest in any subsidiaries, any inventory or equipment that is held by the Seller for the benefit of third parties or is leased from third parties, which inventory and equipment is as listed on pages 73-76 of Schedule 1.01 (collectively, the "Excluded Assets").
