INTELLECTUAL PROPERTY TRANSFER AND LICENSE AGREEMENT

This Intellectual Property Transfer and License Agreement ("IPTLA") is made effective as of August 4, 1997, by and between Hoechst Celanese Corporation, 30 Independence Boulevard, Warren, NJ 07059 ("HCC") and Clariant AG, Rothausstrasse 61, CH-4132 Muttenz, Switzerland ("Clariant").

WITNESSETH THAT:

WHEREAS, HCC and Clariant are parties to an Asset Purchase Agreement by which Clariant is purchasing the specialty chemicals business of HCC and to which this IPTLA is attached; and

WHEREAS, HCC owns intellectual property, including patents, know-how and trademarks relating in whole or in part to the specialty chemicals activities to be transferred,

NOW, THEREFORE, in consideration of the premises and of the promises hereinafter made, it is agreed as follows:

Article 1. Definitions

1.9 The term "QUALIFYING DATE" means January 1, 1997.

1.10 The term "TRADEMARKS" means the trademarks listed in Schedule 1.10 to this IPTLA.

Article 2. Transfer and Licensing of TECHNOLOGY and PROTECTED RIGHTS

Article 4. Trademarks

- 4.1 HCC hereby assigns to Clariant the TRADEMARKS , together with the good will associated therewith, subject to any prior licenses that may have been granted and subject to obtaining any consents that may be required from third parties.
- 4.2 HCC shall promptly prepare at HCC's expense and provide to Clariant assignment documents for the TRADEMARKS in due form for recording. HCC shall not be responsible for such recording or fees in connection with such recording.
