

THIS ASSIGNMENT OF TRADEMARKS (this "**Assignment**") is made and entered into effective as of the 9th day of March 2004 by CIBER, Inc., a Delaware corporation ("**Assignor**"), in favor of IDS Scheer AG, a company formed under the laws of the Federal Republic of Germany ("**Assignee**").

WHEREAS, Assignee has requested that Assignor execute this Assignment, as confirmatory of the transaction described in the Agreement, and Assignor has willingly complied with such request.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and intending to be legally bound, Assignor hereby confirms the assignment, transfer and delivery to Assignee of its entire right, title and interest in and to the Trademarks, together with the goodwill associated therewith, the registrations therefor and the right to sue for past, present and future infringement, if any there may be.


