ASSIGNMENT OF U.S. TRADEMARK RIGHTS

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor by these presents, sells, assigns and transfers unto Assignee and its successors, assigns and legal representatives, all right, title and interest in and to the Mark, together with the goodwill of the business symbolized by said Mark, together with the assignment of all rights to sue for past infringement of said Mark and all causes of action (either at law or equity) and the right of recovery, including but not limited to damages, for such past infringement, and the right to receive royalty income, the same to be held and enjoyed by Assignee for its own use and benefit and for the use and benefit of its successors, assigns and legal representatives.

Assignor hereby agrees to execute all further agreements, instruments, certificates and other documents and to perform such other proper acts as Assignee or its successors or assigns

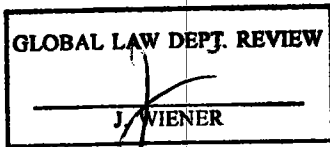
may deem reasonably necessary to secure to Assignee or to its successors or assigns the rights hereby transferred.

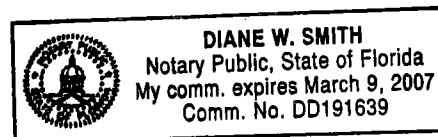
