Assignor further agrees that it will, without further consideration, perform or cause to be performed such lawful acts and to execute or cause to be executed such further documents as Assignee may reasonably request to fully effectuate this Assignment including, but not limited to, the execution of assignments in recordable form in each other jurisdiction where trademark registrations or applications for the Service Marks may be issued or pending.

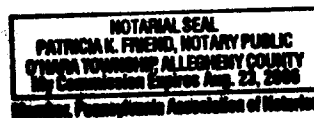
