OF ARTICLES OF INCORPORATION

The undersigned, pursuant to § 13.1-710 of the Virginia Stock Corporation Act, executes these Articles of Amendment and states as follows:

The name of the corporation is: Stock Building Supply Holdings, Inc.

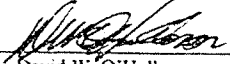
3. The date of adoption of the Amendment was as follows: July 16, 2003.
