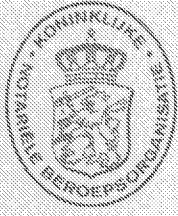

NOTARIAL STATEMENT

I, Christiaan Maria Stokkermans, civil law notary in Amsterdam, the Netherlands,

declare:

- a. Elsevier B.V. (the "**Company**") is a private limited liability company (*besloten vennootschap met beperkte aansprakelijkheid*), duly incorporated and validly existing under the laws of the Netherlands, having its official seat in Amsterdam, the Netherlands, and its office address at Sara Burgerhartstraat 25, 1055 KV Amsterdam, the Netherlands.
- b. The Company was incorporated on 17 December 1979.
- c. The Company changed its name from Elsevier Science B.V. to Elsevier B.V. by deed of amendment of the Articles of Association, executed on 9 January 2003 before me, civil law notary. A ministerial Statement of No Objections, required for the said amendment of the Articles of Association, was granted on 7 January 2003, under number BV 221947.
- d. The Company is currently registered in the Commercial Register under number 33158992.
