**ABSTRACT OF JUDGMENT**

In the above entitled and numbered cause a judgment was rendered in this Court, or other United States District Court as indicated above and registered herein, on the 1<sup>st</sup> day of July, 2003, in favor of Lyrick Studios, Inc., against Big Idea Productions, Inc., in the sum of \$10,306,346.28 (\$9,086,513.00, plus prejudgment interest in the sum of \$1,219,833.28 calculated at the rate of 10% per annum from January 3, 2002, the date this suit was filed, through June 30, 2003), plus post-judgment interest on the entire Judgment being awarded herein, including pre-judgment interest and court costs, at the rate of 1.02% as provided by law.

Costs have been taxed by the Clerk of Court in the sum of \$50,084.37.

Credits reflected by returns on execution in the sum of \$500,000, per Order Denying Plaintiff Lyrick Studios, Inc.,'s Motion to Recover the Full Amount of the Injunction Bond in Addition to the Judgment, But Granting Request to Execute on Judgment entered on July 1, 2003.

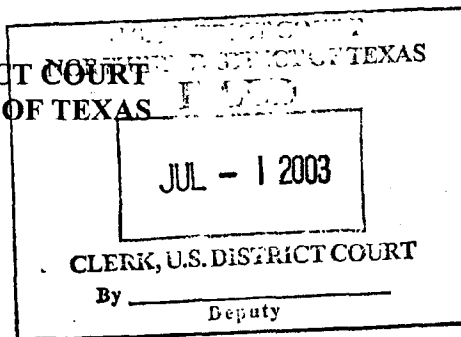

**FINAL JUDGMENT**

This action came on for trial on April 14, 2003, before the Court and a jury. The issues having been duly tried, the jury rendered its unanimous verdict on April 28, 2003, finding for Plaintiff Lyrick Studios, Inc. ("Lyrick") and determining damages of \$9,071,973.00. Prior to trial, the parties stipulated that Lyrick was entitled to recover the additional amount of \$14,540.00 from Defendant Big Idea Productions, Inc. ("Big Idea"). The Court concluded that it should enter judgment for Lyrick on the verdict.

It is, therefore, **ORDERED, ADJUDGED, and DECREED** that Lyrick shall recover from Big Idea the sum of \$9,086,513.00, plus prejudgment interest in the sum of \$1,219,833.28 calculated at a rate of 10% per annum from January 3, 2002, the date this suit was filed, through June 30, 2003, for a total Judgment of \$10,306,346.28.

It is **FURTHER ORDERED, ADJUDGED, and DECREED** that Lyrick is entitled to recover from Big Idea its reasonable attorneys' fees upon determination by this Court after receipt of proof thereof.

It is **FURTHER ORDERED, ADJUDGED, and DECREED** that court costs are hereby taxed against Big Idea, and that Lyrick shall recover its court costs as provided for by law.


It is **FURTHER ORDERED, ADJUDGED, and DECREED** that Lyrick is entitled to

post-judgment interest on the entire Judgment being awarded herein, including pre-judgment interest and court costs, at the rate of 1.02% as provided for by law.

All other relief not granted herein is denied.
