RELEASE OF SECURITY AGREEMENT

Agreement entered into this 24th day of March, 1998, between MENOMINEE PAPER COMPANY, INC., ("Menominee") on the one hand, and GENERAL ELECTRIC CAPITAL CORPORATION, for itself and as agent for certain lenders ("Lenders") (in such capacity, together with its successors in such capacity, and for itself, the "Agent"), on the other hand.

WHEREAS, Menominee, Lenders, and the Agent were parties to a Credit Agreement dated as of December 15, 1995 (as modified and supplemented and in effect from time to time, the "Credit Agreement"), creating certain Obligations of Menominee;

WHEREAS, Menominee, Lenders, and the Agent were parties to a Security Agreement dated December 15, 1995 (as amended, restated, supplemented, or modified the "Security Agreement"), providing for, among other things, a security interest in all of Menominee's personal property, including all of its intellectual property, to secure its Obligations under the Credit Agreement.

WHEREAS, Menominee and Agent entered into a Trademark Security Agreement dated December 15, 1995 (the "Trademark Security Agreement") by which Menominee granted Agent a security interest in certain trademarks, trademark applications, trademark registrations, and trademark licenses to induce Agent and Lenders to incur certain obligations provided for in the Credit Agreement;

WHEREAS, Menominee has satisfied all of its obligations pursuant to the Credit Agreement and the Security Agreement;

NOW WHEREFORE, Agent and Menominee hereby terminate Agent's security interest in the Trademark Rights as granted by the Trademark Security Agreement as follows:

Agent hereby fully releases all of its right, title, and interest in and to the trademark rights as identified in Section 2, Section 4, and Schedule I of the Trademark Security Agreement (collectively, the "Trademark Rights").

In furtherance of its release of its security interest in the Trademark Rights, Agent hereby re-assigns to Menominee its interest in the Trademark Rights, and any and all interest it may have ever had in any trademark of Menominee, including but not limited to the following trademarks:
