ASSIGNMENT OF ASSETS AND REDEMPTION OF MEMBERSHIP INTEREST

THIS ASSIGNMENT OF ASSETS AND REDEMPTION OF MEMBERSHIP INTEREST (this "Agreement") is made this 1st day of August, 2003, by and between VCM, Ltd., an Ohio limited liability company (the "Company"), and GB Retailers, Inc., a Delaware corporation (the "Member").

BACKGROUND INFORMATION

A. The Company's board of directors, managers, and sole member have adopted a plan of complete liquidation (the "Plan").

B. In order to commence liquidation pursuant to the Plan, the Member desires to redeem its membership interests in the Company.

C. The Member desires to receive any property available to be transferred by the Company to it pursuant to the Plan.

PROVISIONS

NOW, THEREFORE, in consideration of the foregoing and the mutual covenants set forth herein, the parties agree as follows:

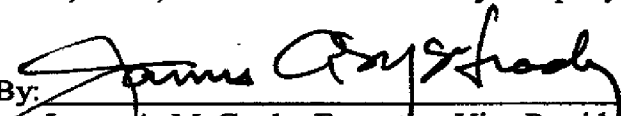
Section 1. **Transfer of Assets and Membership Interest.** In complete satisfaction of the rights of the Member, the Company hereby assigns, transfers and conveys all of its right, title and interest in and to all of its property, real, personal and mixed, both tangible and intangible, whether known or unknown, including, but not limited to, United States Trademark No. 2582696 for "Wheel Tech," to its Member ("Assignment") in accordance with the Plan, effective as of February 3, 2002. Effective October 8, 2003 (the "Effective Time"), the Member shall be required pursuant to Section 2 hereof to deliver its membership interests in the Company to the Company.

Section 2. **Cancellation of Membership Interest.** At the Effective Time, the Member shall tender or transfer to the Company all certificates for any membership interests in the Company which are in the Member's possession, if any, or of which it is the owner of record on the Company's books and records. The President, Secretary or any other authorized officer, director or agent of the Company shall cancel any such certificates delivered pursuant to this Section by marking "CANCELLED" and the date thereof upon the face of each certificate.

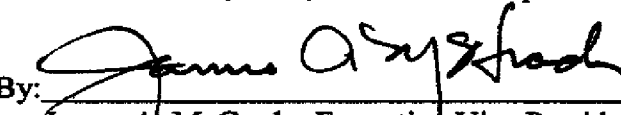
