GRANT OF SECURITY INTEREST

WHEREAS, HELEN KAMINSKI PTY LIMITED (ACN 086 026 879), an Australian corporation (herein referred to as "Debtor"), owns all right, title and interest in and to the trademarks listed on the attached Schedule 1 (the "Trademarks"); and

WHEREAS, Debtor is obligated to BOLLMAN HAT COMPANY (together with its successors and assigns, the "Secured Party"), and, together with Helen Kaminski LLC, has entered into an Amended and Restated Security Agreement dated as of December 30, 2003 (the "Agreement"), in favor of the Secured Party; and


WHEREAS, pursuant to the Agreement, Debtor granted to the Secured Party a security interest in all right, title and interest of Debtor in and to the Trademarks, together with the goodwill of the business symbolized by the Trademarks and the applications for and registrations thereof, and all proceeds thereof, including, without limitation, any and all causes of action that may exist by reason of infringement thereof (the "Collateral"), to secure the payment and performance of the Liabilities, as defined in the Agreement;

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Debtor does hereby grant to the Secured Party a security interest in the Collateral to secure the payment and performance of the Liabilities.

Debtor does hereby further acknowledge and affirm that the rights and remedies of the Secured Party with respect to the security interest in the Collateral made and granted hereby are more fully set forth in the Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein.
