INTELLECTUAL PROPERTY ASSIGNMENT

WHEREAS, prior to the effective date of this assignment, COMTA was a program of Assignor and in that capacity has provided accreditation of massage therapy schools and educational programs;

WHEREAS, Assignee has become a separately incorporated entity that will continue to conduct such accreditation activities;

WHEREAS, Assignor is the owner of all right, title and interest in and to the marks COMTA, COMMISSION ON MASSAGE THERAPY ACCREDITATION and various logos and designs incorporating the COMTA or COMMISSION ON MASSAGE THERAPY ACCREDITATION marks (collectively, the "Marks");

WHEREAS, Assignor is the owner of all right, title and interest in and to United States Trademark Mark Application No. 76/466,224 covering the COMTA certification mark (the "Application");

WHEREAS, Assignee will continue to exercise control over accredited massage therapy schools' and programs' use of the Marks, as such control has previously been exercised by COMTA as a program of Assignor;

WHEREAS, Assignor is the owner of all right, title and interest in and to various written and creative materials and know-how pertaining to the accreditation activities of COMTA, including but not limited to the COMTA Standards of Accreditation and other written materials, forms and manuals, and the COMTA website appearing at www.comta.org, and of all copyrights and other intellectual property rights therein (such rights, together with the Marks, being referred to collectively the "Intellectual Property"); and

WHEREAS, Assignee is desirous of acquiring all right, title and interest in and to the Intellectual Property;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are acknowledged, Assignor assigns to Assignee: all right, title and interest in and to the Intellectual Property, together with any goodwill of the business and activities symbolized by the Marks; the Application and all rights that arise from the Application; all rights to seek other registrations of the Intellectual Property in the United States Patent and Trademark Office or elsewhere; all profit, benefit and advantage that may arise from reproducing or selling material incorporating any Intellectual Property; and all causes of action for, and the right to sue for, any past and ongoing infringement of rights in the Intellectual Property or other violations of the rights assigned hereunder.

Assignor represents and warrants that it owns all right, title and interest in and to the Intellectual Property, and that it has not made any other assignment or pledge of the Intellectual Property, any rights therein or the Application.
