TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT (the "Assignment") is made and entered into as of this 29th day of March, 1999 ("Effective Date"), by and between Heyer-Schulte NeuroCare, L.P., a Delaware limited partnership, with its principal office at 8401 102nd Street, Suite 200, Pleasant Prairie, Wisconsin 53148 USA ("Assignor") and Integra NeuroCare LLC, a Delaware limited liability company, with its principal office at 105 Morgan Lane, Plainsboro, New Jersey 08536 USA ("Assignee").

WHEREAS, pursuant to that certain Asset Purchase Agreement dated as of March 29, 1999 ("Purchase Agreement") among Assignor, Neuro Navigational, L.L.C., Assignee and Redmond NeuroCare LLC, Assignee wishes to acquire and Assignor wishes to assign its right, title and interest in and to the trademarks and the United States trademark registrations and applications for registration identified and set forth on Schedules A and B, respectively, including variations thereof, and the foreign trademark registrations and applications for registration identified and set forth on Schedules C and D, respectively, (collectively, the "Marks") (subject to the existing liens of Fleet Capital Corporation), and the goodwill of the business associated with all of the foregoing;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor does hereby sell, assign, transfer and set over to Assignee its right, title and interest in and to the Marks (subject to the existing liens of

Fleet Capital Corporation) together with the goodwill of the business in connection with which the Marks are used, and all registrations and applications therefor, in the United States and for all foreign countries, including any renewals and extensions of the registrations that are or may be secured under the laws of the United States and all foreign countries, now or hereafter in effect, for Assignee's own use and enjoyment, and for the use and enjoyment of Assignee's successors, assigns or other legal representatives, as fully and entirely as the same would have been held and enjoyed by the Assignor if this Assignment and sale had not been made; together with all income, royalties or payments due or payable as of the Effective Date or thereafter, including, without limitation, all claims for damages by reason of past, present or future infringement or other unauthorized use of the Marks, with the right to sue for, and collect the same for Assignee's own use and enjoyment and for the use and enjoyment of its successors, assigns or other legal representatives. Assignor requests the Commissioner of Patents and Trademarks to record Assignee as the assignee and owner thereof.

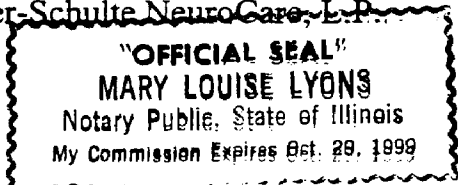

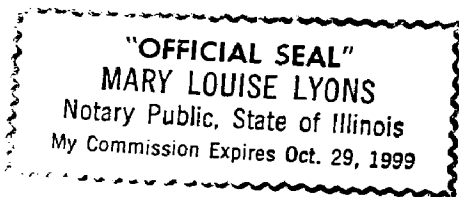
