

### RELEASE OF LIEN IN TRADEMARKS

This RELEASE OF LIEN IN TRADEMARKS is given as of this 27<sup>th</sup> day of February 2004 by U.S. Bank National Association, a national banking association, located at Goodwin Square, 225 Asylum Street, Hartford, Connecticut, not in its individual capacity but solely as Owner Trustee (as defined in the Security Agreement) under the Trust Agreement (as defined in the Security Agreement) ("Assignor") (as successor in interest to State Street Bank and Trust Co. of Connecticut, N.A.), in favor of Sweetheart Cup Company, Inc., a Delaware corporation, located at 10100 Reisterstown Road, Owings Mills, Maryland 21117 ("Assignee").

**WHEREAS**, pursuant to a Trademark Security Agreement dated as of June 1, 2000 (the "Security Agreement"), by and between Assignee and Assignor, Assignee granted a security interest in all of the Assignee's United States and Canadian trademarks, trademark registrations, tradenames and trademark applications that, in each case, were then filed with the U.S. Patent and Trademark Office, any similar office or agency of any state, territory or possession of the United States or any similar office or agency of Canada or used in the United States, any state, territory or possession thereof or Canada, including, without limitation, the trademark registrations and trademark applications listed on Schedule A attached hereto and made a part hereof, and (i) renewals thereof, (ii) all income, royalties, damages and payments due or payable with respect thereto, including, without limitation, payments under all licenses entered into in connection therewith and damages and payments for past or future infringements thereof, (iii) the right to sue for past, present and future infringements thereof, and (iv) all rights corresponding thereto throughout the world (all of the foregoing trademarks, trademark registrations, tradenames and trademark applications, together with the items described in clauses (i)-(iv) of this paragraph, the "Trademarks"); and the goodwill of the Company's business connected with and symbolized by the Trademarks (collectively with the Trademarks, the "Collateral")


**WHEREAS**, the Security Agreement was recorded in the United States Patent and Trademark Office on August 4, 2000 at Reel 2124/Frame 847; and

**WHEREAS**, Assignee has paid in full all of its Obligations and Assignor desires to release its security interest in the Collateral.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby releases its security interest in the Collateral to Assignee and, without representation, warranty or recourse of any kind, reverts the Assignee with full title to the Collateral.
